Human Experimentation

"The question is whether we are to have experiments performed on fully functioning adults and on children who are potential contributors to society or to perform initial studies in **children** and **adults** who are **human in form but not in social potential?** It may be objected that this question implies a **Nazi philosophy**, but **I do not think that it is difficult to distinguish nonfunctioning persons** from members of ethnic, racial, economic, or other groups."

Sordid Vaccine Work

In January 2018, Dr. Plotkin <u>admitted under oath</u> that he conducted the following human experiments:

- Testing of an experimental vaccine on orphans
- Testing of the Rubella vaccine on mentally [handicapped] children
- Testing of an experimental vaccine on babies whose mothers were imprisoned
- Using individuals under Colonial rule to test vaccinations
- Using almost a million people in the Belgian Congo (now known as the Democratic Republic of the Congo) to study experimental vaccines

Vaccines Dr. Plotkin Developed

- Rubella viral strain RA 27/3 (derived from aborted fetal tissue)
- Rotavirus
- Rabies (using aborted fetal cell line MRC-5)

Contributed to:

- Anthrax
- Cytomegalovirus
- Varicella (using aborted fetal cell lines WI-38 & MRC-5)

Fetal Organs Used in Research

In one Wistar Institute study authored by Dr. Plotkin, 76 normally developing babies at gestational ages three months and older were used in his research. Dr. Plotkin admitted under oath that the organs harvested from the aborted and dissected babies include:

- Pituitary Glands
- Hearts
- Kidneys
